## STUDENT INTERNET ACCESS AND USAGE PARENT/GUARDIAN ACKNOWLEDGEMENT

### CKSD INTERNET ACCESS AND CLOUD-BASED INSTRUCTION

Central Kitsap School District supports cloud-based instruction and collaboration. In a cloud-based instructional environment, many of the staff and student resources are web-based and require internet access. To support this model, all staff and students in CKSD have access to a Google Suite for Education (G-Suite) account. This account provides access to instructional apps, online curriculum resources, and is active as long as the student is enrolled in CKSD. This educational version of G-Suite provides a self-contained environment for students and staff to create, collaborate and share documents and projects. G-Suite for Education's core services are ad-free, and non-personally identifiable user data is only used to improve G-Suite services. You can find the G-Suite Terms of Service here:

**Student Responsibility:** Student use of the internet and G-Suite follows the expectations in the district's Acceptable Use Agreement (2022P) and Student User Consent and Release Form (2022F). Although any cloud-based resources can be accessed outside of school, use of the account on the ckstudents.org domain is bound by the same rules and guidelines as use of any student account on the CKSD network. These accounts are intended for educational purposes whether or not the student is at school.

**School Responsibility:** CKSD and G-Suite student accounts created by the school district will be managed at the district level. In school, teacher supervision and Internet filters are used to prevent access to inappropriate content and to ensure that student use of digital tools follows the Internet Acceptable Use Agreement. Student accounts can be accessed by administrators at any time. Digital citizenship instruction is included as part of instruction of web-based tools. **Parent/Guardian Responsibility:** Parents assume responsibility for the supervision of internet use outside of school. Parents are encouraged to discuss rules and expectations for using internet-based tools, including G-Suite.

**Gmail:** Students in grades K-5 will not have access to Gmail (unless specially requested by the school, and only with parent permission). Students in grades 6-8 will be issued filtered Gmail accounts for educational use with parent permission (please return signed permission form). Students in grades 9-12 will be issued filtered Gmail accounts for educational use.

### PARENT/GUARDIAN ACKNOWLEDGEMENT

- I understand that my child will have access to the internet when logged onto district computers/devices connected to the CKSD network.
- I understand that CKSD uses filters to comply with the Children's Internet Protection Act (CIPA), and that CKSD is committed to protecting my child's personal information by complying with the Children's Online Privacy and Protection Act (COPPA)
- I acknowledge that my child will have a student Google Suite for Education (G-Suite) account for instructional use while he/she is a student in the Central Kitsap School District.
- I acknowledge that my child will have filtered access to YouTube (YouTube access is limited to "Restricted Mode" when students connect via their CKSD user account, and is intended for educational use).

All students in CKSD are issued a computer network login and G-Suite account which provides internet access and access to instructional resources. *If you would like to request that your child NOT have access to the internet, please read and sign the internet opt-out form which is available from the office manager at your child's school.*
